

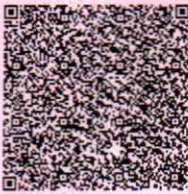

  - d) Fire Prevention & Fire Safety Measures/Arrangement have been tested and are found in working condition.


**Consequences for non-compliance**

3. The following provisions are known to me.

- i) Any Self-Certificate, if found false or otherwise, will be treated as wilful criminal negligence and shall be brought into justice under provision of prevailing law of the land.
- ii) The owners or occupiers, as the case may be, individually or jointly, who are liable to provide fire protection and life safety measures in the building or part of the building or premises, who at any time, fail to comply shall be deemed to be in default. In case, where a fire safety certificate is issued earlier shall remain suspended for a period from the date of the notice for non compliance and Fire Safety Certificate shall be cancelled after giving owner or occupier an opportunity of hearing to show-cause by following due process of law.


